



Dear Parent or Guardian:

Now that our school year is in full swing, we want to alert you to an exceptional opportunity for you and for our schools.

Arizona is fortunate to offer a tax credit on state taxes. This applies to all Arizona taxpayers. Any taxpayer may contribute up to \$200.00 per individual or \$400.00 per couple, to any fee-required extra-curricular activity offered at the school of their choice. This is a direct credit, not a deduction. That means it is subtracted from the taxes you owe and is fully refunded for up to \$400.00. For example, if you regularly owe \$400.00 a year in Arizona state income taxes and give \$400.00 to a school, you would owe ZERO for the that year you gave a tax credit. It literally costs you nothing to give the money. It comes back to you as a credit, refund or reduction. Remember this is for STATE taxes only.

This is a wonderful win/win situation. As a taxpayer, you are able to reduce your tax burden while contributing directly to the school programs of your choice. Our local schools would welcome any amount as a tax credit contribution.

All of our Career and Technical Student Organizations (CTSO) are eligible to receive this funding. We can accept any amount from \$10.00 to \$400.00. Your WAVE School Board and WAVE Administration ask for your participation.

We urge you to help share this message with all Arizona taxpayers, your friends, neighbors and relatives. It's time to take advantage of this ability to benefit our students. Join us in our efforts towards excellence as we remember "Educating Everyone Takes Everyone."
